Rules of Election:

Election to the Vestry is by simple majority (50% of ballots cast plus one). If it is necessary to have additional ballots, those people who are elected on previous ballots are removed from the running. The slate is also reduced to no more than two nominees per position by removing those people who received the least number of votes.

When one of the positions being filled is a partial term, this position is determined by drawing lots among all those elected. This is done following the Annual Meeting. Vestry members filling a one year term are eligible to run again for a three year term. Vestry members filling a two year term are not eligible to run again until they have been off the Vestry for two years.

As always - what a wonderful day to be in Manassas and to be with each other at Trinity!

This year we spent working getting to know each other and working hard to understand our shared space in Manassas. You see, it is here and now that we are called together to share God's work of telling about Forgiveness, Grace, and Love.

Along the way we did a number of important things. I hesitate to start listing all that we did because inevitably I will leave something out - If that something is a ministry or project you are involved in, I deeply apologize for my poor memory! And please know that I deeply appreciate your participation in the work we do together.

Any way, this year I remember working with you to:

- 1. Make the financial controls a little more secure. We did this by separating the function of "bookkeeper" from the Treasurer's position. We hired Jerry Pankey to take over the bookkeeper functions and the Vestry elected Matt Snyder to be our Treasurer. Many thanks to them both!
- 2. Reimagined our various Outreach Ministries to be more sustainable, serve more people, and integrate more Trinity Parishioners into providing hands-on help in our work for the people of Manassas and Prince William County. Of special note is the work of the Food Ministry with Pete Trapp and Jennifer Smith's leadership, the Altar of Hope with Christian Cobb and Lisa Wells providing guidance, our work with SERVE (an emergency shelter for families) with Barbara Yow and Sara Woods providing coordination, and our work with Boxes of Basics with Marian Patey providing coordination.
- 3) Said Goodbye to Eric, and Hello to Margaret. Margaret Lacy came to us with a career full of growth, joy, music, and God's love. We are deeply honored to have her with us helping us grow our repertoire, skills and courage.
- 4) Said Goodbye to Carol and Hello to Jennifer (JJ) Cooper. JJ's leadership has helped us expand the number of hours we are available during the week for drop-ins, open to us Reading Programs, Game Nights, and other social events, revamp our functional technology, and continue to bring joy and laughter to our church environment.
- 5) Welcomed Elio Smith to a new position in the Church, that of Porter. Elio is instrumental in helping us expand our fellowship ministry by providing a consistent weekly presence in the church. Through the simple acts of opening the doors, making sure the restrooms are clean, brewing coffee, and baking coffee Elio deepens our welcoming ministry.
- 6) Wrote and Adopted Parish By-Laws that are congruent with the Canons of the Diocese of Virginia. The vestry under the leadership of our Sr. Warden Virginia Cantu and especially

Vestryperson Gene Molinelli, wrote a set of by-laws for our parish. They are designed to be user friendly, while keeping us in compliance with the Canons of the Diocese of Virginia. If you would like a copy please see JJ. There are also copies in the Library and the Church Office for your perusal.

- 7) Welcomed new leadership with new ideas and direction to our Children's ministry. A new "Godly Play Ethos" whereby the children are encouraged to share and tell the stories of God's love with each other has been adopted. Many thanks to Erin Price for her leadership in this function, we deeply appreciate her clarity, administrative skills, and vision that allow us to build on the hard work that Brenda Smith and Brenda Randall did as we pulled ourselves out of COVID.
- 8.Redesigned and strengthened our Stewardship Processes. Stewardship Education and engagement is not about the simple act of Fundraising, rather it is the far more complex act of education. Education about finances yes, but also gratitude, joy, and giving, all of which are ultimately rooted in Love. Anne Burns brought her considerable skill and energy to this task. Any parish's Stewardship Journey is complicated by cultural challenges to financial openness and the lack of transparency this brings, but we have put ourselves on a great path!
- 9) Re-Created our Finance Committee. Our Finance Committee has been re-formed to help the vestry take a deeper look at how we invest our financial resources in God's ministry. They help us think about what our budget should look like, how funds should be invested outside the parish into equities, etc., how funds should be managed, and how we keep our financial future safe and secure. Many thanks to our Sr. Warden and Treasurer for their work on this program. &
- 10) We Loved. We loved God in our worship, each other in our listening and care, and our wider world in our work and prayer.

As I said above, I know I've left so much out - but ten is such a good number to end on! Thank you for all your support and work this past year. This is work that never ends, because God's love never ends.

Invested Fund Definitions

The Clergy Housing Fund

The Trinity Church Housing Fund is established to enable the parish to supply housing allowances for the clergy home ownership. The Fund was established in 1988 with proceeds of the sale of the rectory. Additional funds were added to the corpus of the fund in 2022 when the shared equity agreement with the Rev. Stuart Schadt was completed. Although the corpus and interest of this Fund is available to be used as designated by the Vestry, the corpus is to be maintained and enabled to grow. The corpus can be invested in clergy housing arrangements that offer the potential for future earnings.

The Mary Rixey, Frances Rixey Coles and Cornelia Lewis Fund

This investment fund was established by a bequest in the will of Mary Rixey. The Fund was established in 1937. The Fund was increased by gifts from Cornelia B. Lewis in 1997. The

interest of the Fund is administered under the direction of the Vestry of Trinity Church. The corpus of this Fund is managed under the guidelines of The Trinity Growth Fund.

The Memorial Fund

The Memorial Fund is used to buy items for the sanctuary and for worship. Contributions are made to the Fund as a memorial to those who have died or as a thanksgiving offering. Expenditures from this Fund are under the direction of the Rector, Altar Guild and Vestry. Sometimes gifts to this Fund are designated for specific items. It is common that members of the church designate this Fund as the fund to receive memorial gifts.

Library Fund

The Charlotte Brown Library Fund was created in December 1993 as a memorial to Charlotte Tiffany Brown. Its purpose is to re-establish and maintain a parish library.

The Organ and Piano Fund

Funds are added as memorials and from other sources occasionally. We hope that this fund will provide for the care and maintenance of the organ and pianos and, when necessary, their eventual replacement.

JBT Thornton Trust

This trust was established in 1918 when the will of J.B.T. Thornton gave a bequest of ten (10) shares of bank stock for its establishment. Judge Thornton had served as judge of the Sixteenth Judicial Circuit of Virginia since 1907 and previous to that time had been Commonwealth's Attorney and superintendent of schools for Prince William County. As a member of Trinity, he served on the Vestry and Senior Warden for many years.

Until 1997, Crestar Bank was the Trustee of the Trust. In 1997, the Vestry of Trinity became the Trustee of the Trust. Trinity is a named beneficiary of the trust and receives fifty percent of the dividend income with no restrictions on how the vestry designates its' use. The other half is distributed for use to benefit the elderly of the greater Manassas area in a manner designated by the Vestry acting as trustee of the funds. The Thornton Trust is invested with the Beach, Blake, and Associates in a portfolio managed by Interactive Financial Advisors.

Food Pantry 2023

After giving out food during the first week of January 2023, the hard decision was made to temporarily close our Food Pantry as we had run out of funding. We quickly regrouped and strategized ways to make this ministry sustainable while still helping to feed our food-insecure neighbors.

Although officially closed, we continued to give out some food to those in need during the winter and spring months. We also continued to receive some packaged food through our partnership with Agape Love in Action (ALIA) during that time. When our Food Pantry was able to reopen in June, our partnership with ALIA ended and we began a new partnership with Northern Virginia Food Rescue (NVFR). NVFR provided us with a great amount of non-perishable packaged foods through October at which time their Covid funding ran out. However, we instead began to receive rescued food such as produce, fruit, dairy products and baked goods from NVFR. In addition, we partnered with St. Thomas United Methodist Church which provides us with bread products on our days of distribution. These partnerships allow us to be better stewards of our funds as we have been able to offset some of our normal costs with the free food.

In November, we began offering assistance to food insecure residents at Quarry Station Seniors Apartments by providing 14 bagged lunches each month. These bags are lovingly packed by Trinity's youth. In addition, we have begun taking food provided by NVFR that is not distributed when our Food Pantry is open to Quarry Station.

Our Food Pantry would not be sustainable without our amazing volunteers and the very generous contributions of both food and financial assistance by the congregation of Trinity for which we are enormously grateful. We also want to acknowledge the very successful food drive at Pennington School spearheaded by Molly Carasco, the food donated by cast, family members and attendees at two of the Oliver performances put on by Prince William Little Theater at the Hylton Center, the food donated by participants in Rebecca Olsen's Perpetual Wellness classes, a cash donation by the Manassas Men's Club, the cash received through the fundraiser at Foster's Grill organized by JJ, the \$315.00 raised through the sale of Jesse Tree ornaments made and donated by Jennifer Smith, and the funds raised through the GotSneaker Campaign which not only provided \$75.00, but also kept 82 sneakers out of the landfill.

Although our Food Pantry was only open for a portion of the year, we distributed an amazing 409 dinner bags and 833 lunches to those in need in 2023. We wish each of you could see what an enormous impact this makes and the gratitude of those we serve. Thank you so much for your support of this vital ministry.

Other Reports

In-person worship Worship was offered at 7:30am, 8:30am, and 11 am on a weekly basis.

<u>Live-streaming:</u> Our 11:00 service is live-streamed every week, as was our 5:30pm and 7:30pm services on Christmas Eve and our 11:00am service on Christmas Day.

<u>Adult Forum:</u> Adult Forum returned this summer with presentations by members, by the VP of Historic Dumfries Inc. and by Boxes of Basics. We also held a Halloween party for the Sunday School, and a scavenger hunt.

Weekday Worship: A service is held on Wednesdays at 12:00 noon.

<u>Home Communions</u> were conducted by clergy and by four lay Eucharistic ministers.

<u>Lay Pastoral Ministry:</u> These teams, headed by Brenda Randall, send out love and greetings, prayers of healing and Happy Birthdays to our whole community! With each card, the love for each other is gently given and even more warmly received. (To get a card, please make sure we have your birthday on record!)

Worship Ministry Volunteers: Lay Readers assist in our worship by reading the lessons and leading the psalm. Prayers leaders lead the prayers printed in the service bulletin. Ushers help seat people, collect the offerings, and direct worshipers to communion. Greeters stand at the door and welcome people to church. And acolytes (young people in grades 5 to 12) serve at the altar. If you are interested in these ministries, please contact the church office.

<u>Flower Guild:</u> The Flower Guild provides the flowers we see at worship services. Mary Delia Stokely is Flower Guild Chairman; contact her at 703-368-1424 if you are interested in joining this Guild.

Altar Guild: The Altar Guild sets up the altar area for worship. Joanne Georg chairs the Altar Guild; if interested in joining, please contact her at 703-754-9401.

The Vestry

Our Senior Warden is elected on nomination of the Priest in Charge. The Vestry also elects a Junior Warden.

<u>The Charlotte Tiffany Brown Library</u> has books for borrowing and browsing. The Smith family reorganized the library over the past two years, and we invite you to stop in and see the library.
